About the Program

Sudden cardiac arrest is a leading cause of death in the United States every year. Cardiopulmonary Resuscitation (CPR) is a combination of chest compressions and breathing given to victims that are considered to be in cardiac arrest. CPR helps to provide critical blood flow, oxygen and delivery of energy nutrients to the heart and brain, until the person regains consciousness or Emergency Medical Services (EMS) or professional help arrives on the scene.

In this way, immediate CPR plus defibrillation within three to five (3-5) minutes of collapse, may reduce chances of sudden cardiac arrest and permanent damage.

This course has been designed to help you acquire the skills you will need to effectively respond in an emergency situation and is designed for the newly certified or the recertification and will be taught by Rohn Hull of CPR Associates, Inc. who is a Regional Faculty Member for the American Heart Association.

ABOUT THE SPEAKER

Dr. Heymann graduated from the University of North Carolina School of Dentistry. He is past Chair and Graduate Program Director of the Department of Operative Dentistry and currently is Professor of Operative Dentistry at the UNC School of Dentistry.

Dr. Heymann is particularly active in the clinical research of esthetic restorative materials and participates in a dental practice devoted largely to esthetic dentistry.

He is a member of Academy of Operative Dentistry, the International Association of Dental Research, and is Past-President and a Fellow of the American Academy of Esthetic Dentistry. ABOUT THE PROGRAM

Temporomandibular disorders (TMD) are a group of musculoskeletal disorders of the masticatory system. These disorders are common and dentists are the primary care providers. Therefore every dentist should have a sound understanding of TMD so that the most appropriate care will be selected for the patient. Often simple care can make big differences in the patient's quality of life. In the past, dentists have attempted to manage their TMD patients utilizing standard dental approaches which have not always proven to be successful. In fact our profession has many concepts and theories that attempt to solve musculoskeletal problems with dental therapies, many of which have little to no scientific supported. This presentation will describe the present evidence that either support or disprove these concepts, including how occlusion may or may not affect TMD. Other areas that will be discussed are etiologic considerations and treatment strategies, including the use of occlusal appliances. This text is used in most of the United States dental schools as well as in many other countries. It has been translated into eleven different foreign languages. In addition to this text, Dr. Okeson has authored the sixth edition of *Bell's Orofacial Pains* which is published by Quintessence Publishing Company. This text is translated into six different foreign languages and widely used in orofacial pain programs throughout the world.

Dr. Okeson is an active member of many TMD and orofacial pain organizations holding many offices and serving on numerous committees and boards. He is a past President of the American Academy of Orofacial Pain and former editor of the Academy's Guidelines. He is a founding Diplomate and past President of the American Board of Orofacial Pain. This course is designed for those who want to learn how to treatment plan dental attachments to implants. Many case designs are discussed ranging from two to eight implants.

It covers many treatment planning options for implant attachment prosthetics as well as the differences between implants and natural teeth

Attachment and implant dentistry provide a very functional and esthetic means to achieve the treatment planning objectives of the dentist as well as overwhelming patient satisfaction. Attachments are rigid or resilient connectors that redirect the forces of occlusion. They are stress attenuators and absorbers. Their function is to protect and preserve soft tissue and bone, as well as provide retention and cosmetic alternatives. Implants are devices that are rigidly fixated to bone. This characteristic differentiates them from natural teeth. Their long term success depends on bone characteristics, occlusal relationships and loading forces as well as the types of attachments selected.

The course explores the rationale for using attachments as connectors to implants. It clarifies the role of the restorative dentist who initiates treatment planning the amount of implants that will insure success through the use of study models, wax bites, occlusal set ups and surgical stents. A clear understanding of what needs to be achieved must be established first by the restorative dentist and communicated to the surgeon and to the patient. Implants must be placed where they can be successfully restored and not just where available bone is. Treatment planning options from two to ten implants are presented. Various precision and semi-precision attachment cases are reviewed along with numerous types of resilient and non-resilient bar units, joints, studs, magnets, screws, and various accessory attachments. Numerous clinical variants are considered such as the quantity and quality of available bone, various ridge relationships, number of implants placed, the anterior-posterior spread, osseointegration and loading protocols are explained and elaborated.

Treatment plans are presented using attachments and implants in a variety of removable or fixed prosthetics approaches. Clinical cases are reviewed and a logical approach to the treatment planning of attachment and implants is presented which insures long term success and patient satisfaction. Participants will gather knowledge, excitement and confidence enabling them to utilize attachments and implants in their daily practice immediately.

Participants are encouraged to bring questions which will be discussed throughout the presentation as well as any of their past experiences with attachments.

Upon successful completion of this course, the attendees will:

- Have a fuller understanding of how rigid or resilient attachments work to insure successful implant prosthetics

- Explore the treatment possibilities using bars and stud attachments
- Learn how to do occlusal set ups first and work with surgical stents

- Learn the treatment planning differences between implants and natural teeth
- Learn how to successfully treatment plan two to eight implants using attachments
- Learn how accessory attachments work to enhance retention and esthetics
- Gain a new level of confidence in treatment planning attachment retained fixed, segmented or over-denture prosthetics

There has been great interest in the popular media about the link between oral cancer and oral sex. Unfortunately much of the information is misleading or just plain incorrect. Dr. Huffines will give an evidenced-based presentation on what is known about the human papilloma virus (HPV) and head and neck cancers so that you will be able to correctly answer questions from your patients about this topic. In addition, you will receive an update on non HPV cancers. Topics will include prevention, new diagnostic technologies, advances in radiotherapy and chemotherapy, root caries, maxillofacial prosthetics, management of xerostomia, and controversies in hyperbaric oxygen use. Oral cancer kills one American every hour of every day. Those who survive face significant challenges to their oral health. This is a great opportunity for the entire dental team to

gain a comprehensive understanding of the field of oral oncology from a clinician involved in every aspect of this challenging area of dental practice. With the correct techniques you can make a huge difference in the quality of life for these patients.

A Letter From the ONSDS President

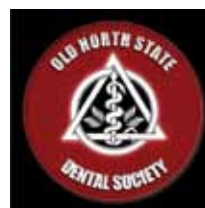
Dear Friends and Colleagues of the North Carolina Dental Society,

What Every Dentist Needs to Know About Temporomandibular Disorders: *The Facts and the Fantasies*

Friday May 16, 2014, 9:00 AM – 12:00 PM and 2:00 PM – 5:00 PM

Temporomandibular disorders (TMD) are a group of common musculoskeletal disorders of the masticatory system, and dentists are the primary care providers. Every dentist should have a sound understanding of TMD so that the most appropriate care will be selected for the patient. Simple care often can make a big difference in a patient's quality of life. Managing TMD patients with standard dental approaches has not always proven successful. In fact, many concepts and theories for treating musculoskeletal problems with dental therapies have little to no scientific support. This presentation will describe current evidence that either supports or disproves these concepts, including how occlusion may or may not affect TMD. Other areas to be discussed are etiologic considerations and treatment strategies, including the use of occlusal appliances. This presentation will attempt to separate the facts from the fantasies in the area of TMD.



Dr. Jeffrey P. Okeson, DMD

Dr. Okeson is a 1972 graduate of the University of Kentucky College of Dentistry. After completing an internship in public health, he joined the University of Kentucky faculty in 1974. Currently, he is Professor and Chair of the Department of Oral Health Science and Director of the College's Orofacial Pain Center, which he established in 1977. He has worked with business leaders in over half of the states in the U.S. to create non-partisan

political research organizations.

In December, 2012, John Davis was named as one of the Top 10 "Political Influencers" in North Carolina by *Campaigns & Elections* magazine, a national publication for political professionals.

A native of Graceville, Florida, Davis is a graduate of William Carey University in Hattiesburg, Mississippi. He and his wife, Kathy, live in Raleigh. They have five grown children.

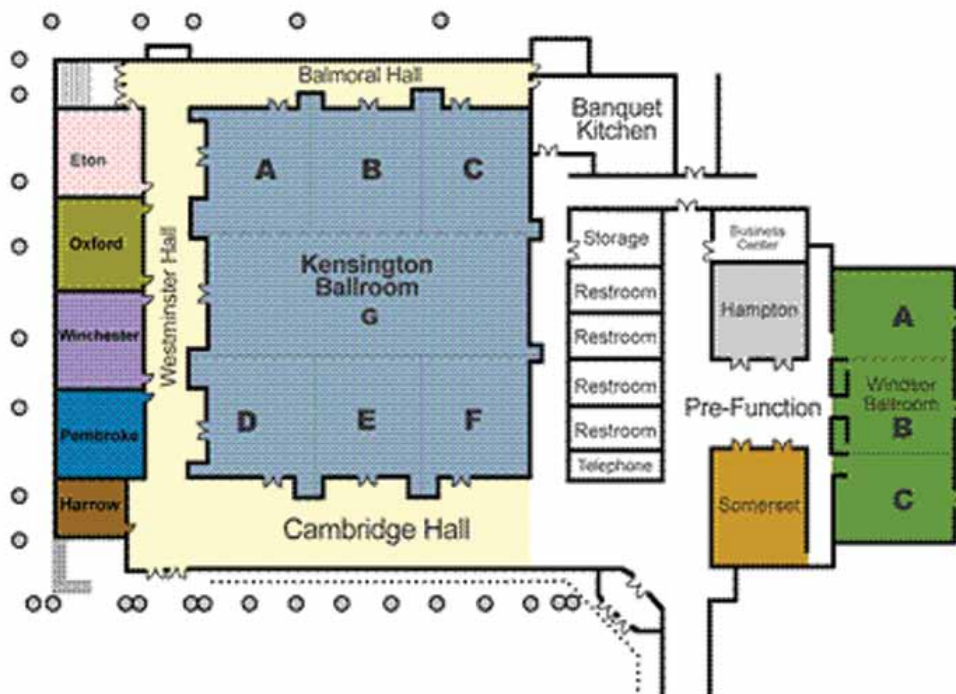
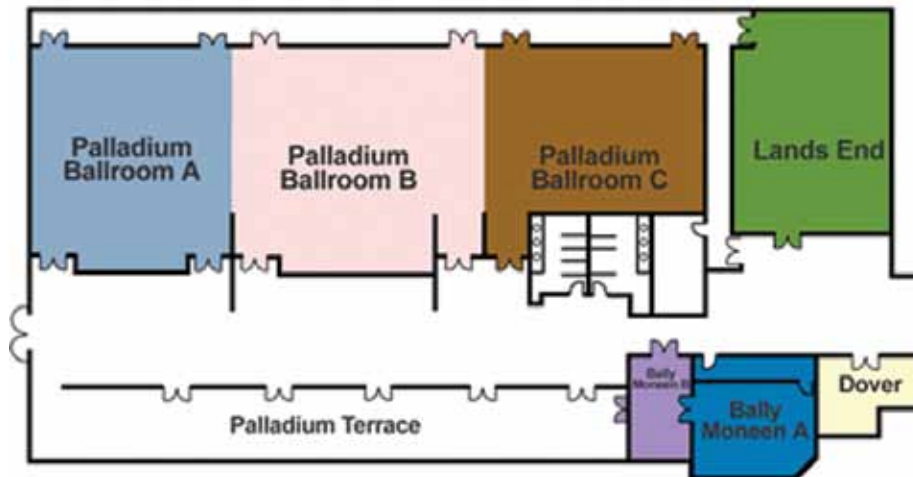
