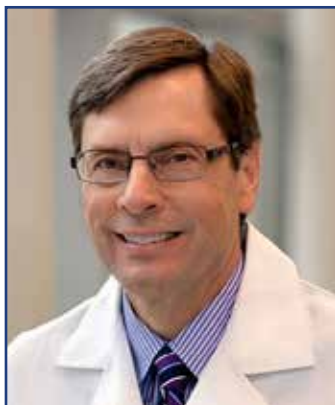

DFCon Houston invites all those engaged in the field of diabetic foot care, wound healing, limb salvage, and amputation prevention to submit an abstract for DFCon's Second Annual Poster Competition.

To enter the competition, at least one author or co-author of each submitted abstract must register for and attend the 2018 DFCon meeting.

A panel of DFCon experts will grade and accept posters for presentation. The three best poster abstracts will be rewarded; the first author of each of the three best abstracts will receive \$500 as well as a 50% reduction in DFCon registration fee and an invitation to the 2018 DFCon faculty dinner.
