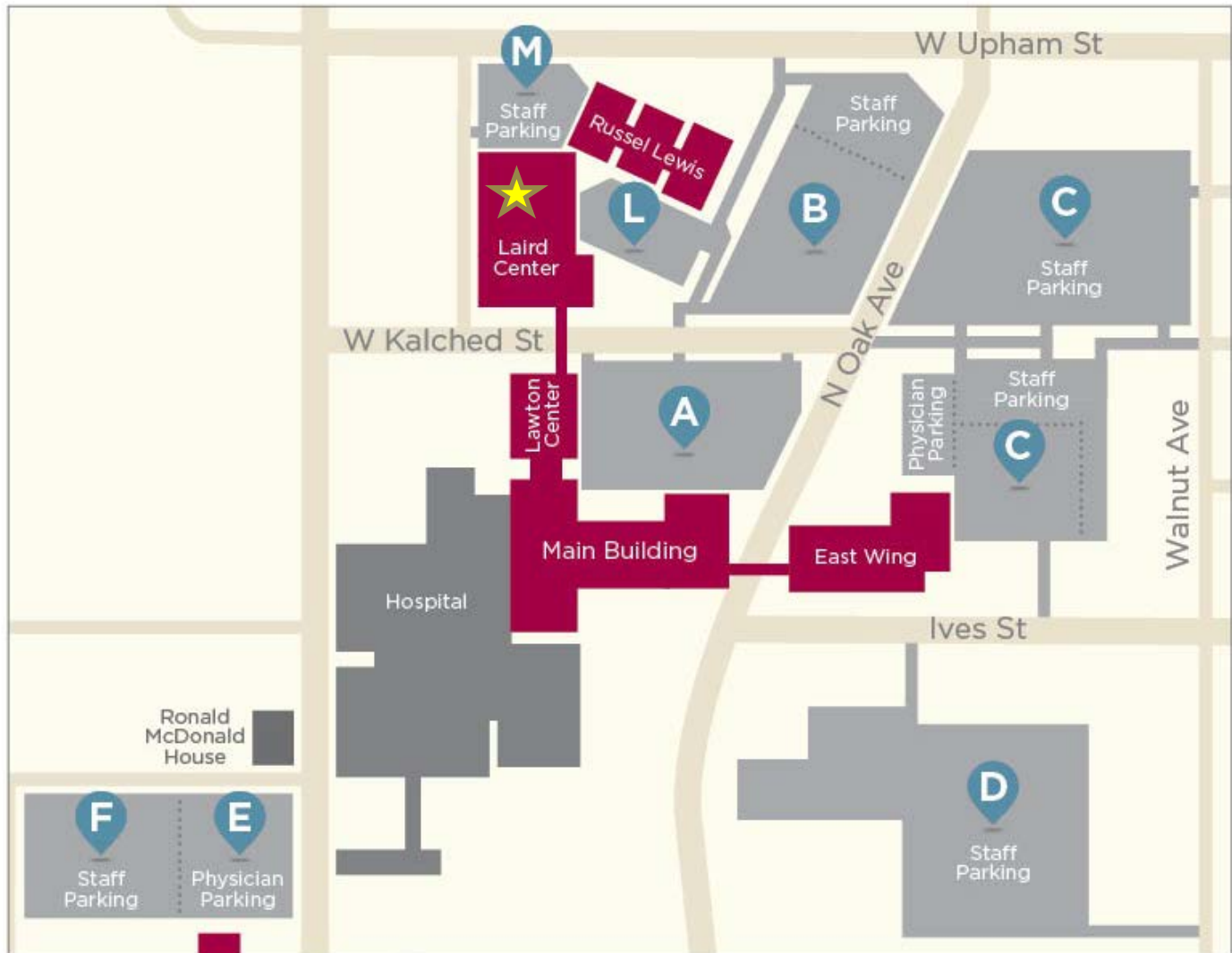
If your registration is dependent upon approval from your agency, please do not hesitate to register now. You may cancel your registration without penalty until Friday, September 28, 2018.
