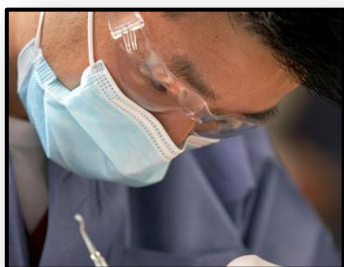
### Edward Herschaft, DDS
