TERMS AND CONDITIONS

BOOKING AND PAYMENT

All prices are quoted in Australian dollars and exclude GST (Goods and Services Tax). GST is required to be applied to all packages at the rate prevailing at the date of invoicing or payment, whichever is earlier. Sponsorship packages and exhibition space will be allocated only on receipt of the online booking form or a signed hard copy booking form.

Confirmation will be sent together with a tax invoice for the full amount. The invoice is payable within 20 days of date of tax invoice. If the payment is not received within this timeframe, then you relinquish your right to the requested sponsorship package and exhibition platform. Benefits can only proceed when payment has been made. All payments should be made in Australian dollars by bank transfer.

No sponsor will be allowed to setup their exhibition platform until full payment has been received. Sponsors may not assign or sublet any part of their exhibition space. Sponsors consent to their contact details being shared with Symposium suppliers and contractors.

Registration of company attendees will be done separately upon confirmation of your sponsorship. All exhibition staff (complimentary or otherwise) must be registered.

DELEGATE LIST

Email addresses of attendees who have agreed to name disclosure are provided to all sponsors and exhibitors. Kindly ensure that when contacting delegates, involuntary disclosure of information of attendees does not occur and the communication confines within the guidelines of anti-spamming protocols. Non-compliance will result in provision of the list for future meetings without the relevant email contacts.

- > Between 1 December 2021 and 28 April 2022, you are liable for 50% of the package selected
- > From 28 April 2022, you are liable for 100% of the package selected

The Organising Committee reserves the right to cancel the Symposium in the case of circumstances beyond its control. In such a case all monies paid to date will be refunded in full less any expenses incurred. The liability of the organisers will be limited to that amount.
