How It All Started

In 1975 in San Diego, a group of professionals from law enforcement, child welfare, probation, social work, medicine, and others gathered together with one thing in mind . . . to create a coordinated community response to child abuse and neglect. From this visionary group, ideas became a reality in the founding of the San Diego County Child Abuse Coordinating Council, the Child Protection Team for child abuse case review, and what is now the Chadwick Center at Rady Children's Hospital-San Diego.

In January 1976, the new hospital-based child protection program, now the Chadwick Center, formally began its journey to provide quality programs and services for abused children. In the beginning, the program was simple with few staff providing physical abuse medical evaluations and a prevention program with parent aide home visitors. In January 1979, a defining moment in our growth came when the Center began a contract with the City of San Diego to provide medical evaluations of victims of child sexual abuse.

So much has happened in the intervening 40 years—many exciting, creative, innovative ideas, services and programs. Over that time span, funding dictated a variety of programs; however, Evaluation, Treatment, Intervention, Research and Education remain as the core programs at the Center.

In 1985, after several years of staging local and regional conferences, we presented a successful statewide conference which emboldened us to launch a national conference in 1986. There were a whopping 125 attendees, and over the years, we have grown to 2000! This is our 30th year in offering a distinctly multidisciplinary international conference known for its quality evidence-based sessions given by renowned expert faculty.

C1: THE LAW AND PSYCHOLOGY OF INTRODUCING CHILDREN'S STATEMENTS IN COURT

Presenters: Thomas D. Lyon, John E.B. Myers

We now have a pretty good idea of how to interview children so as to maximize productivity and minimize suggestibility. But what happens if the case goes to trial? This training will highlight the ways in which advances in child interviewing can improve the process by which children are heard in court. This two part pre-conference seminar will provide an overview of the current research on problematic sexual behavior (PSB) in children, including research based guidelines for identification of PSB and factors contributing to the development and maintenance of PSB. Research indicates active engagement of caregivers and addressing behavioral management strategies are key to successful outcomes. Approaches to evidence-based practices for children with PSB and their caregivers and how to educate and collaborate with professionals in the formal systems involved with these families will be addressed.

C3: ADVANCED ISSUES IN CHILD SEXUAL ABUSE

This one day advanced training workshop will discuss important current and emerging issues in child sexual abuse-what's new, what's novel, and what needs improvement. Included will be a review of the current scientific literature regarding timing and types of forensic collections, advances in STI testing including current recommendations, and the significance of anogenital findings. In addition, updates of child trafficking and the medical evaluation will be reviewed. Finally, sexualization of children in the media and how it relates to child sexual abuse will be explored.
