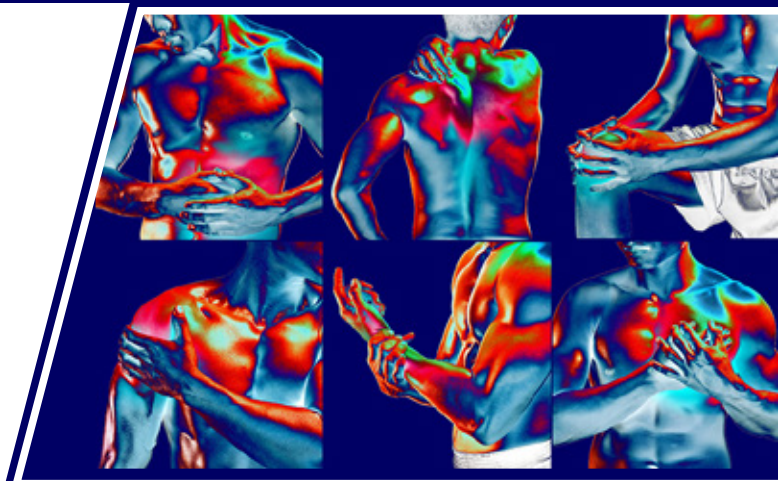


Chronic Pain Management Conference
