Ohio has ranked in the top five for opioid overdose deaths since 2014. The focus of SCOPE is the application of scientific principles in the development of prevention and educational strategies for reducing substance use disorder (SUD). One area of focus for SCOPE was SUD education of healthcare professionals. Here, we discuss the development and implementation of an educational course and interprofessional escape room for SUD and OUD.

Leading in Times of Trauma: Helping Frontline Heroes Cope with Burnout

Throughout the pandemic, overrun hospitals were often referred to as combat zones and health care workers as frontline soldiers. Because of the demand and stress they are under, pharmacists are more likely to suffer from PTSD than the general population. Research shows that members of the health care team, pharmacists included, are more prone to making errors when under a lot of pressure. Dr. Sairany, a trauma-informed pharmacist who has personally served at the frontline in combat zones, will share her life experiences and discuss effective strategies that can be used by pharmacy staff to prevent burnout when leading in times of trauma.

Healthcare professionals from every corner of the landscape have an important role to play in the fight against the opioid epidemic. The 340B Drug Pricing Program is administered by the federal government's Health Resources and Services Administration (HRSA). Manufacturers that offer their products in the Medicaid program are required by law to offer 340B prices on those drugs. Hospitals that serve indigent and uninsured patients and clinics recognized as government grantees that provide primary care to low-income individuals qualify for 340B discounts. The 340B Program enables covered entities to stretch scarce federal resources as far as possible.
