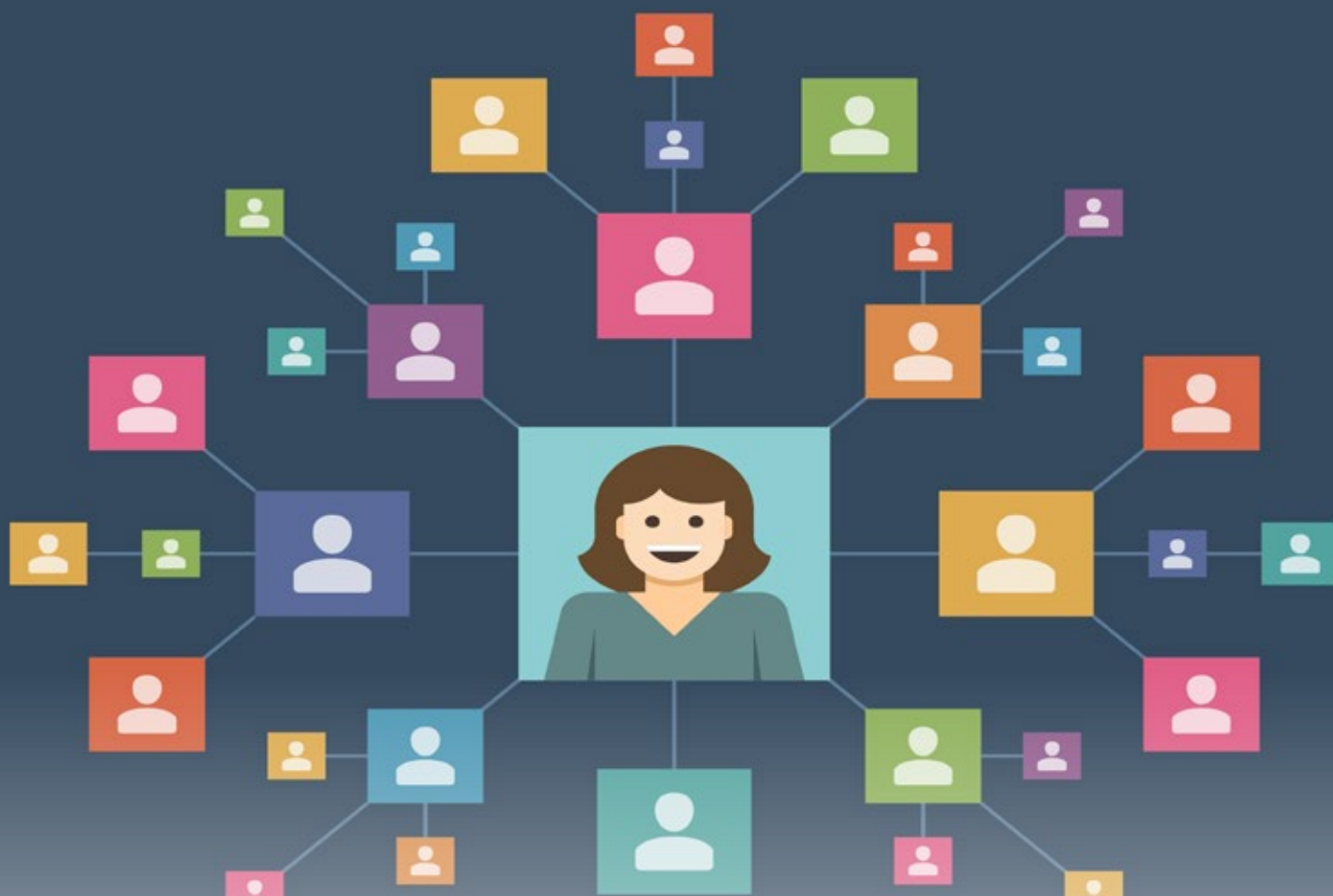

"Good information governance in a health or social care organisation is essential for maintaining the safety and effectiveness of care, efficiency and trust. In a good organisation, information about patients and those seeking care will be shared appropriately among members of the team responsible at every stage of the care pathway. There will be no improper use of confidential personal data; patients and service users will be able to confide in the professionals without fear of unauthorised disclosure. And in a good health and social care system, there will be strict rules to allow data to be used for other purposes such as research and planning better services without breaching confidentiality...Bringing about appropriate sharing of information at every stage of the care pathway required a fundamental change in professional and organisational culture. It was not realistic to expect that this would be achieved within a single year.... in too many organisations across England, the necessary change in culture has not been apparent" Information Governance Oversight Panel, January 2015

The Government published "Information: to share or not to share" in response to the Caldicott Review over a year ago. Health and Social Care organisations should now be ensuring the recommendations are working in practice. This conference provides a practical guide to effective information sharing specifically in a mental health setting in line with the recommendations from the Independent Information Governance Oversight Panel and the new Information Governance Alliance. The conference will also include a national update on information sharing in mental health, an in-depth look at decision making around information sharing, including an update on the legal framework, developing and implementing an effective information sharing protocol for frontline staff, Information Sharing and working in partnership with the police, Information Sharing in complex cases: Learning from multi agency sharing agreements and the experiences of MARACs, information sharing for mental health crisis, a case study outlining a Caldicott Guardian's Perspective from a Mental Health Trust and a session focusing on sharing information with carers and relatives.

"We strongly support working closely with families. Obtaining information from and listening to the concerns of families are key factors in determining risk. We recognise however that some people do not wish to share information about themselves or their care. Practitioners should therefore discuss with people how they wish information to be shared, and with whom" Consensus Statement on Information Sharing and Suicide Prevention, DH January 2014

"The sharing of information may be difficult, but is often crucial to the ongoing wellbeing of both patients and carers.... Healthcare generally has increasingly been seen as a partnership between providers, patients and their families. However, in mental health there are differences of opinion about which information can be shared with carers. The sensitive nature of mental health problems means that there can be particular difficulties in relation to confidentiality and the sharing of information." The Royal College of Psychiatrists
