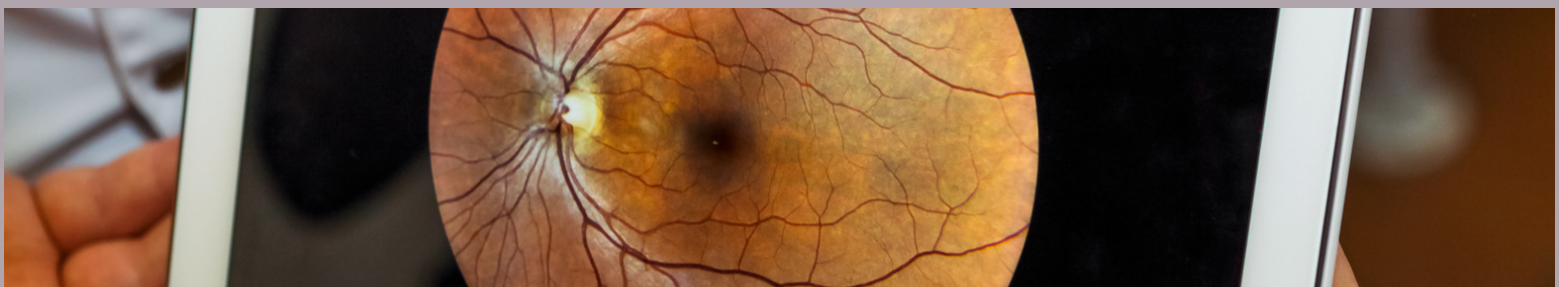
No Wonder You Don't See Well, How Eye Disease Affects Vision (1 Hour)
