The Mental Capacity (Amendment) Bill was introduced to the House of Lords on Tuesday 3 July and seeks to replace the current system known as ‘Deprivation of Liberty Safeguards’ (DoLS), the new system will allow the NHS, rather than local authorities, to make decisions about their patients, allowing a more efficient and clearly accountable process (DH2018).
