SYNOPSIS:

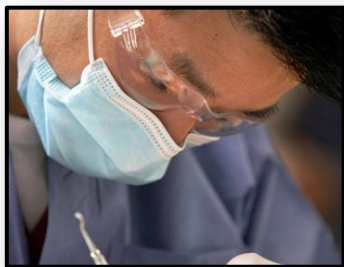
Tianjin, China. Dr. Herschaft is one of the quality assurance officers for the UNLV
