Ways to Practice EBM in 2016: Why We Need Both Evidence-Based & Experience-Based Medicine

Dr. Pepe demonstrates that despite evolving pressure toward evidence-based medicine (EBM), even formal studies and clinical trials have limitations. This is where another type of EBM – “experience-based medicine” in this case -- becomes an invaluable tool. Dr. Pepe will evaluate challenges to some sacred cows in resuscitation medicine and discuss how a clinician's careful observations and experience in individual patient scenarios can lead to a revolution of improved patient care and safety.

The Definitive Airway Talk: Is Prehospital Endotracheal Intubation Elemental or Detrimental?

Dr. Pepe tackles the controversy surrounding the use of endotracheal intubation in the prehospital setting, examining potential deleterious effects and worsened outcomes. He will analyze the reasons why prehospital endotracheal intubation (PHETI) has received a bad reputation and then delineate the factors that are responsible for poor performance. His session will help you identify common red flags that may indicate the need for more discretion and limitations in PHETI use to ensure optimal patient care.

Mr. Bolleter's powerful session highlights the reality of medical misadventure and crew resource mismanagement. While serious complications in emergency medicine are rare, understanding the implications to our practice is crucial. Mr. Bolleter takes a step-by-step journey through media relations, professional and personal camaraderie, communications, patient care and critical care interventions — focusing on the final responsibility that rests with each of us. This presentation begins with a cold marble headstone, but it holds the promise of illuminating our collective efforts and improving patient care.

Dr. Dahman evaluates the use of intraosseous vascular access as beneficial in mass casualty and disaster settings. His session encourages the use of IOs in emergency response scenarios to avoid delays in resuscitation and discusses factors such as choice of landmarks, insertion errors, and the impact of personal protective equipment on gaining IO access.

Ms. Drone provides insight for prehospital providers in identifying maternal and fetal trauma by comparing it to similar non-OB trauma. Her session breaks down

the physiologic changes in the pregnant patient and the interventions available in the trauma setting. She will present, discuss, and decipher current recommendations for management of OB trauma for EMS providers to optimize maternal and fetal outcomes.

Acute Spinal Cord Injury

Dr. Garvey will start at C1 and work his way down in an exploration of acute traumatic spine and spinal cord injuries, focusing on the anatomical basis of neurological deficits that are commonly encountered from these injuries. He will review current guidelines for the initial assessment and management of the spinal trauma patient, including best practices for screening for potential spinal cord injuries.

Chemical Extrication: Removing the Torture from Extrication

Mr. Gooch will discuss the utilization of sedation and analgesia in trauma patients requiring extrication. Most patients who require extrication have suffered painful injuries including fractures and internal injuries. One problem that can hinder patient removal is resistance by the patient due to fear and/or pain. Utilizing sedation and analgesia, known as chemical extrication, the removal process can be facilitated and be less stressful and torturous for the patient and providers.

Normal saline, Lactated Ringer's, hetastarch – or nothing at all? Dr. Pickett reviews 15 years of resuscitation science and its impact on trauma care. His session examines the new frontiers for prehospital resuscitation, discussing the pitfalls of common practices and the cutting-edge science of blood products and resuscitation monitoring. Dr. Pickett will evaluate new transfusion protocols and ratios, field emergent blood transfusion, and the use of freeze dried plasma.

Bumps and bruises and other blunt trauma injuries are common in the pediatric population. But what about penetrating injuries? Mr. Seastrom works to

sharpen your knowledge of the less common, but no less lethal, penetrating trauma in pediatric patients. From gunshot wounds to falls causing impalement, this session uses vivid pictures, videos and even little humor to describe common penetrating injuries in the pediatric population.

Wilderness medicine expert Mr. Symons identifies techniques for assessment of the hypothermic patient, focusing on the constraints of the austere environment. His session illustrates the Swiss Staging System as the most accurate non-thermometer temperature estimation system. He exposes the limitations of traditional hypothermia description terms and demonstrates how a better estimation of the patient's core temperature, using the four stages defined by the Swiss Staging System, is key to determining appropriate treatment and transport decisions.
