Information on data privacy

If you do not want us to continue using your address for information about further med update europe seminars, you have a statutory right of revocation (s. 28 (4) of the German Data Protection Act (Bundesdatenschutzgesetz BDSG)). Terms of payment and cancellation for registration

Fees shall be paid on issuance of the invoice. This invoice for the participation shall only be issued to the attendee and shall bear his or her invoice address. Please pay by money transfer free of charge only after you have received the invoice, stating your name and the invoice number. If you should need to change your registration, please address wikonect GmbH via post, fax or e-mail. In the event of cancellation up to 14 days before commencement of the congress a processing fee of 50,- Euros will be charged.
