Legal Conditions

If a third party takes over the contract from a guest, both parties are liable for payment of the invoices as well as for the rebooking fees. MCI Deutschland GmbH's liability for damages – not including personal injuries – is limited to three times to the total invoice amount, provided that the damage is not caused deliberately or in a negligent manner.
