Keynote Presentation: Countering Pain Stigma Through Enhanced Conceptual Understanding

GENERAL SESSION

The primary claim in this speech is that understanding the concept of stigma is key to addressing pain stigma in clinical nursing contexts. The talk begins with a fundamental conceptual model of stigma and explains what it means to identify stigma as structural. Next, the presentation applies the model to pain specifically and both describes the phenomenology of pain stigma and links it to two ethical frameworks of justice (epistemic justice and health justice). Emphasizing the ways in which pain stigma silences people in pain, the analysis then turns to ways in which nurses and advocates can counter pain stigma as a structural problem. The talk advances a multilevel approach for addressing pain stigma at micro-, meso-, and macro-levels and gives examples of interventions at each level. The analysis also evaluates the strengths and weaknesses of interventions at each level and ultimately endorses the use of laws and policies as primary tools for nurses and policymakers to use in ameliorating pain stigma.
